ROADWAY MAINTENANCE

Dunlawton Avenue (S.R. 421) from I-95 to Nova Road (S.R. 5A)

Volusia County

PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) is resurfacing segments of Dunlawton Avenue (State Road (S.R.) 421) between the Interstate 95 (I-95) interchange and Nova Road (S.R. 5A) in Port Orange, Volusia County, to extend the life of the roadway. Work also includes the restoration of pavement markings and traffic loops, which are devices embedded into the roadway that detect vehicles approaching a signal.

Not all travel lanes of Dunlawton Avenue will be resurfaced in this project. As this is maintenance work, only the sections of the roadway identified as needing repair will be repaved.

WHAT TO EXPECT

Motorists should expect intermittent nighttime single lane closures as follows:

- Between the hours of 8 p.m. and 7 a.m. on Taylor Road from just west of S. Williamson Boulevard to Dunlawton Avenue just east of the I-95 interchange
- Between the hours of 6 p.m. and 7 a.m. on Dunlawton Avenue from just east of the I-95 interchange to Clyde Morris Boulevard (S.R. 483)
- Between the hours of 6 p.m. and 11 a.m. on Dunlawton Avenue from Clyde Morris Boulevard to Nova Road (S.R. 5A)

Electronic message boards and other signage will be used to direct traffic around lane closures. Access to side streets, residences, and businesses will be maintained throughout the duration of the project. Motorists and pedestrians should exercise caution while traveling through work zones.

Uneven pavement is a common, unavoidable roadway condition with resurfacing projects as the contractor must place different layers of asphalt during various phases of construction. Road conditions during construction are short-term and will become less apparent as the project nears completion.


