

Access Management

Access management is the careful planning of the location, design, and operation of driveways, median openings, interchanges, and street connections. With the introduction of a median, the access management classification becomes Access Class 5 (restrictive), the same as in the 2007 design plans. The graphic below shows the spacing criteria that will be used.

Project Overview


This project includes the widening of State Road (S.R.) 500/U.S. 441 from four to six lanes from Lake Ella Road to Avenida Central (at Griffin Avenue) along with the addition of bicycle lanes and sidewalks. Also, the existing bridges over County Road (C.R.) 25 will be removed and replaced with an at-grade intersection. Other project features include: signing and lighting, aesthetics (including landscaping), access management updates, and a plan for maintenance of traffic during construction. The design phase for this project is anticipated to be completed by April 2019 with construction expected to begin in early spring of 2020.

The existing bridges at the S.R. 500/U.S. 441 intersection with C.R. 25 will be removed and replaced with an at-grade intersection. East of S.R. 500/U.S. 441, the relocated C.R. 25 will allow for right and left turns onto S.R. 500/U.S. 441. There also will be a traffic signal at this intersection. The existing C.R. 25 will end as a cul-de-sac. West of S.R. 500/U.S. 441, C.R. 25 will end as a cul-de-sac, just before S.R. 500/U.S. 441.

Typical Section Hermosa Street to Avenida Central (at Griffin Avenue)




