### PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) is making safety and operational enhancements along State Road (S.R.) A1A (Ocean Shore Boulevard) from north of E. Granada Boulevard (S.R. 40) to north of Roberta Road in Ormond Beach.

The project incorporates features proposed through the North Ormond Beach Area Coalition planning effort. Enhancements include alignment shifts to encourage safer driving speeds, curb and gutter improvements, and the addition of left turn lanes at the intersection of Neptune Avenue.

To improve pedestrian safety, a new 6-foot-wide sidewalk will be constructed on the east side of the road where space allows, and a 10-foot-wide shared-use path will be built on the west side. Existing pedestrian curb ramps will be upgraded to meet current Americans with Disabilities Act (ADA) standards. Midblock crossings with raised sections and Rectangular Rapid Flashing Beacons (RRFBs) will be installed to enhance safety. Lastly, traffic signal improvements, lighting upgrades, and drainage modifications will also be added along the corridor.

### WHAT TO EXPECT

During construction, motorists should expect intermittent lane closures and traffic shifts throughout the corridor. Pedestrians and cyclists should expect detours. Road users are advised to follow all posted signage and detour information. Certain driveways along the project corridor may experience limited access; therefore, the contractor will coordinate closely with affected property owners for any necessary work.

Electronic message boards and other signage will direct traffic through the work zone. The level of work activity and noise will vary during different construction phases. Please note that the construction schedule may change due to weather or other unexpected conditions.
